SECTION 4 : FIRST AID MEASURES

In the event of splashes or contact with skin :

Watch out for any remaining product between skin and clothing, watches, shoes, etc. In the event of an allergic reaction, seek medical attention. Remove contaminated clothing Wash skin thoroughly with water Do not use solvents or thinners

In the event of swallowing :

Do not give the patient anything orally. In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor. Seek medical attention immediately, showing the label. Keep at rest. Do not induce vomiting
